

—ANNUAL MEETING—

Home for Aged and Infirm Colored Persons, 4400 Girard Avenue.

THE Thirty-First Annual Meeting of the Contributors of the above named Institution was held at the Home, Sixth month 13th, 1895; William Still presiding.

The meeting was opened with prayer by Rev. Samuel Jones and the singing of the hymn "My Country, 'tis of Thee."

The minutes of the last meeting were read and approved.

The Annual Report of the Board of Managers was submitted and read by Rebecca Conard; on motion it was referred to the incoming Board of Managers for publication.

The Treasurer's report was read and referred to the incoming Board, as usual; also the Physician's.

The Chairman appointed the following contributors a committee to bring forward names of suitable persons to serve as Officers and Managers for the ensuing year, viz.: Lydia E. Pennock, Henrietta S. Duterte, Samuel Emlen and Rev. H. L. Philips.

The Committee proposed the following (see page 3), who were unanimously elected.

After the business of the meeting was concluded, the Rev. V. O. Connell, from the State of Mississippi, addressed the meeting, showing a strong contrast between the Northern and Southern States in works of charity, although the Southern people are awakening to a duty they owe to the poor and aged of their section.

The Rev. Mr. Stitt from North Carolina interestingly addressed the meeting somewhat in the same strain as the previous speaker, but differed as to the extent of the backwardness of the Southern people in their works of charity. He stated that the Colored people, having faith in God, faith in themselves and faith in the

future, are, and will, work out their destiny to the satisfaction of all.

Fanny M. Coppin was called upon and spoke in her usual eloquent strain, and expressed great thankfulness to the Giver of all good for the care and advancement of Colored people in having the privileges allowed them in these latter days so long denied by their more favored brethren.

The Rev. Mr. Stitt sang a solo "The world is growing better every day." Mr. Butler gave an affecting recitation "I am seventy-two today." Thomas Walter made a few humorous remarks, and with the singing of the hymn "Blow ye the Trumpet, Blow" by Margaret Jones, in which the old folks joined, the meeting adjourned.

- ANNUAL REPORT -

THE Board of Managers of the "Home for Aged and Infirm Colored Persons" feel they have but little that is new to offer in this their Thirty-first Annual Report.

Yet we hope by thus bringing our work and its needs before the public to arouse an increased interest in this most worthy charity.

At the time of our last report there were under our care 111 persons. During the year just ending there has been 40 admissions 5 men and 35 women. No. of deaths 19; 5 men and 14 women. One left voluntarily, making our number at the present time 131.

In the sixth month last Israel H. Johnson, for many years a member of the Board and Treasurer of the Corporation, passed from works to rewards. Although unable for a long time to take an active part in the administration of affairs, there are not a few of us who will long remember his devoted interest in the Home and its Inmates.

John Gibson, an inmate known through the house as Father Gibson, and said to be 123 years of age, died 6 mo. 20th. His fervent devout spirit and the cheerful resignation with which he bore the infirmities of age, not the least of which was almost total blindness, conveyed many instructive lessons to those who came in contact with him.

While there has been no epidemic among our old people, and but few cases of pronounced or specific illness, there are many afflicted ones. And chronic cases of pain and discomfort continually tax the patience and ingenuity of our Physican, who so successfully mingles sympathy with his prescriptions that it is sometimes difficult to determine which has been the most powerful restorative.

The Board greatly desires to be able to compensate this faithfulness in a more substantial manner than by an increase of appreciative words.

Competent Committees of Women Managers have made weekly visits throughout the year, inspecting the condition of the Institution, assisting the Matron and housekeeper in matters of discipline, ministering to the wants of the aged ones, soothing imaginary or

real troubles and by cheerful words of interest and encouragement adding variety to a life which at times must grow monotonous.

The Committee on Management with a view to release the Matron from some of the details of housekeeping and allow her more time for the personal care of the inmates have re-organized the working plan of the house with satisfactory results.

There has been no change during the year in the heads of the different departments, and we feel that each has done his and her duty so far as they knew, amidst the numerous difficulties constantly presenting.

During the past few months some of the less feeble of the women have pieced together outsides for seventeen comfortables.

Those who are able also assist in mending and preparing vegetables for the table. While the men cheerfully render whatever service they can throughout the house.

The Parker Building, which was dedicated last 6th mo. is rapidly filling up. In its various appointments it adds much to the comfort of the family.

The extreme cold of the past winter and the increased space to be heated, severely taxed our steam heating plant. But by placing radiators in the halls of the new building and stoves in those of the old, there was but little real discomfort experienced.

A fresh impetus has been given to the interest in religion by the possession of the beautiful chapel in the Parker Building. The religious meetings which are regularly held here have been largely attended by the inmates and others.

The various National holidays continue to be looked forward to with a keen interest and the feasts provided from time to time for both body and mind have been thoroughly appreciated. An account of these may be found in the list of events for the year. To those who contributed to these entertainments, the Board herewith tender their sincere thanks, fully realizing how largely their efforts have promoted the happiness of this large family.

The women of the Board and the Co-operative Committee have added a large bakery to the conveniences of the Home. We now bake our own bread and find it more satisfactory and less expensive. The cost of this has been met by voluntary contributions, and by the receipts from a musical and literary entertainment the performers giving their services gratuitously.

The moving of the laundry into the basement of the new building is a great improvement, giving ample room in well ventilated apartments.

A room in the old building has been appropriated to the use of the hired help, to be called the "Helps Parlor," where they may spend their leisure time socially with books and games, thereby doing away with the necessity of always going out for an evening's enjoyment.

The Home is greatly in need of a diet kitchen, where special food for the sick may be prepared. A room has been set aside for this purpose and also one in the new for the Physican, but owing to lack of funds we have not felt at liberty to incur the expense of equipping either of them. We are also anxious to fit up a workshop for the men, where much time could be pleasantly and profitably spent in doing things suited to their ability and strength.

We would be exceedingly glad if some of our friends would help us out in these three very desirable improvements.

Though having greatly increased the capacity of the Home and the size of our family our funds have not grown in the same proportion. Many of our most generous contributors have been removed by death, and each year finds our number decreased. The so called "Hard Times" have also materially shortened our income.

Believing that rightly organized and administered charity is a part of the Lord's work we are encouraged to thus present our needs. And while thankfully acknowledging all that kind friends have done for us in the past, we again appeal to the generous hearted and sympathetic to fill the vacancies in the list of contributors, thereby affording us that substantial aid which is necessary to carrying on the good work.

MEMORIAL.

Mary Ann Shaw.

The death of Mary Ann Shaw, Eighth month 2, 1894, brings to mind the early history of our Institution, for it was through her perseverance that it was established at so early a date.

Eliza Perry, a worthy colored woman in whom she was interested, being obliged in her advanced years to seek shelter at the Almshouse, convinced her of the need of a Home, and prompted her to urge its establishment.

When informed by Maurice Hall that the matter had been agitated and that Stephen Smith had inserted in his will a legacy of \$10,000 for this object, she was not satisfied with the delay and sought to interest her friends, and collected the first contributions.

The wisdom of this promptness has been abundantly manifested in our history and particularly in the fact that during his lifetime Stephen Smith donated four times as much as he had intended to bequeath, besides liberally remembering the Home in his will.

CHARTER OF INCORPORATION.

Whereas, the undersigned citizens of this Commonwealth have, together with other citizens, associated for the purpose of establishing in the City of Philadelphia a Home for Aged and Infirm Colored Persons, and are desirous of being Incorporated agreeably to the provisions of the Act of the General Assembly of Pennsylvania, entitled "An Act to Confer on Certain Associations of the Citizens of this Commonwealth the Powers and Immunities of Corporations, or bodies politic in law." They therefore declare the following to be the objects, articles, and conditions of their said association, agreeably to which they desire to be incorporated, viz:

TITLE.

1st. This Association shall be called "The Home for Aged and Infirm Colored Persons."

OBJECT.

2d. The objects of this Association shall be the relief of that worthy class of colored persons who have endeavored through life to maintain themselves, but from various causes are dependent upon the charity of others.

ARTICLES AND CONDITIONS.

3d. The officers shall be a President, Vice-President, Secretary and Treasurer, who shall perform the duties usual to those positions, and a Board of Managers, twenty-four in number, who will make all needful rules and regulations, subject to the approval of the Association at its annual meeting, to which they shall submit a report of the proceedings. The officers shall be *ex-officio* members of the Board.

4th. A quorum of the Association shall be fifteen, and of the Managers, ten. The Managers shall meet at least once in each month.

5th. At each annual meeting, two auditors shall be appointed to examine the Treasurer's account previous to its presentation at the next annual meeting, and report as to its correctness.

6th. Respectable colored persons may be admitted into the Home, or boarded therein, with the consent of the Visiting Committee, in accordance with the rules which the Managers may adopt for the Government of the Institution.

7th. The terms of membership of the Association shall be an annual contribution of two dollars. The payment of twenty-five dollars shall constitute a life membership.

8th. The Association shall meet annually, for the election of officers and other business, on the second Fifth-day (Thursday) in the Sixth month (June) of each year, at such time and place as may be agreed upon, of which two week's notice shall be given by the Managers.*

9th. The clear yearly income of real and personal estate held by the Association shall not at any time exceed the sum of thirty thousand dollars.

10th. The Association shall have the power to make By-Laws, not inconsistent with this Charter nor the laws of the land, and to alter and annul the same at pleasure, and a failure to elect officers at any time shall not dissolve this Corporation.

11th. If any member shall die or resign, the vacancy may be filled by an election, at a stated meeting of the Board of Managers, of one to serve in his or her stead until the next annual meeting of the Association.

In the matter of the Incorporation of "The Home for Aged and Infirm Colored Persons."

And now, this second day of December, A. D. 1867, the Articles of Incorporation of "The Home for Aged and Infirm Colored Persons" having been heretofore, to wit, on the thirteenth day of November, A. D., 1867, filed in the office of the Prothonotary of said Court, and due notice having been inserted in a newspaper printed in said County, in due conformance to law; on motion of Edward Hopper, it is declared and decreed that the persons so associated under such articles shall, according to the articles and conditions in said instrument set forth and contained, become and be a Corporation or body politic in law.

And it is further ordered and directed that the said Charter of Incorporation shall be recorded in the Office for the Recording of Deeds in and for the said County of Philadelphia. And on the said instrument being so recorded, the persons so associated or meaning to associate, shall according to the objects, articles and conditions in said instrument set forth and contained, become and be a Corporation or body politic in law and in fact, to have continuance by the name, style, and title in said instrument provided and declared.

In testimony whereof, I have hereunto set my hand and affixed the seal of the said Court, this thirteenth day of December, A. D. one thousand eight hundred and sixty-seven.

BY-LAWS.

ARTICLE I.

The managers shall meet on the second Fourth-day in every month, at such time as may be agreed upon.

ARTICLE II.

Special meetings may be called by the chairman, or at the request of any three members.

ARTICLE III.

All reports of committees shall be made to the Board in writing.

ARTICLE IV.

The meetings of the Board shall be conducted according to the Rules of Order usual in similar bodies.

ARTICLE V.

Standing committees on the following subjects shall be appointed by the chairman at the first meeting in each current year:

- 1st. A Committee on Management.
- 2d. A Committee on Admissions.
- 3d. A Committee on Property.
- 4th. A Committee on Supplies.
- 5th. A Committee on Religious Meetings.
- 6th. A Committee on Interments.
- 7th. A Committee on Finance.
- 8th. A Committee on Discipline.

ARTICLE VI.

The Committee of Management shall consist of the women members of the Board. They shall have a general supervision of the internal arrangements of the Home, and shall propose to the Board any regulations or measures which may be needed for its government. They shall divide themselves into the following subcommittees:

1st. A House Committee of two, to be appointed monthly in rotation; to visit the Home each week, and endeavor to be present once during meals. They shall make themselves acquainted with the situation and wants of the inmates, generally direct the concerns of the family, and report their observations in a book provided for this purpose.

2d. A Clothing Committee of four, who shall superintend the making and distribution of clothing, and give directions in regard to any industrial employment of the inmates.

ARTICLE VII.

The Committee on Property and Finance shall consist of the men members of the Board, and shall have charge of the real estate and financial affairs of the Home.

ARTICLE VIII.

The Committee on Supplies, in conjunction with the Matron, shall make all necessary purchases for the Home.

ARTICLE IX.

The Committee on Interments shall make all needful arrangements for the funerals of our inmates, and at least one of them shall be present on such occasions.

ARTICLE X.

The Board shall appoint annually one or more Physicians, to look after the health of the inmates.

RULES.

Rule 1.—The Matron shall have the general charge of the Home, and keep it in neat order, under the direction of the Committee of Management. She is to enforce the rules and see that suitable nourishment is provided for the sick. She must be respectful and kind to every one in the home, and attentive (without partiality) as their circumstances require. She will promptly check any quarreling or other improper conduct in the inmates, and if necessary, report the same to the Visiting Committee. She shall keep a record of all clothing sent to the Home, and furnish the Committee with a monthly account thereof. She will be expected to go through the house about 10 o'clock P. M., and see that all unnecessary fires and lights are extinguished.

RULE 2.—No person shall be admitted to the Home but such as bring satisfactory testimonials of the propriety of their conduct and the respectability of their character.

Rule 3.—Those received in the Home must be at least 60 years of age, and shall pay to the Treasurer the sum of one hundred and fifty dollars. All who are admitted will be on probation for a period of six months. If their conduct during that time is not satisfactory, they will be retained no longer, but will be charged board for the time they may be residents in the Home, at the rate of two and a half dollars per week, which is to be deducted from the sum paid for admission, the balance of which is to be returned to the party paying the same.

Rule 4.—Any property or personal effects which an applicant my be possessed of must be made over for the benefit of the Home, prior to admission therein; and if any inherit property whilst in the Home, and prefer remaining, the said property must likewise be transferred to the institution; all such transfers being recorded in a book kept for that purpose.

Rule 5.—Colored persons over the age of sixty, of respectable character, and furnishing satisfactory references, may be boarded in the institution upon such terms as the Managers may decide, but

shall be subjected to the same rules and have no privileges different from other inmates. Satisfactory security must be given for the regular payment of the board, previous to their admission.

Rule 6.—No boarder shall be received or continued in the Home to the exclusion of those entirely dependent. Two week's notice, however, must be given for the removal of any boarder.

RULE 7.—A register shall be kept of the names of all applicants, the persons by whom they are recommended, their place of residence, and the report of the Committee on Admission thereon, and any information that may be deemed important.

Rule 8.—Those who are pensioners on any benevolent institution or society, it is expected, will have their pensions continued to assist in their support, and at their death the funeral expenses shall be paid by said societies.

Rule 9.—None but the Physician of the institution or his substitute, shall attend the inmates, unless he should request a consultation with another practitioner. If any of the inmates or their friends desire other than the regular Physician of the Home, they may, with the consent of the attending Physician, be at liberty to employ such; provided the same shall be without expense or any responsibility on the part of the institution.

Rule 10.—After rising in the morning, and again before retiring at night, all who are able shall be assembled in a suitable room, and a chapter from the Bible read to them, after which an opportunity shall be offered for silent or vocal worship.

Rule 11.—Religious meetings shall be held in the Home on the First day of the week, for those not desirous of attending elsewhere.

Rule 12.—Any of the inmates desirous of visiting their friends (on their written invitations) must obtain permission from the Matron, nor absent themselves at any time without permission.

RULE 13.—No stimulants or liquors to be used in the Home unless ordered by the Physician, and then to be administered by the Matron.

Rule 14.—All visitors shall be properly treated and shown through the Home, especially those visiting for religious purposes. Visitors will not be admitted before 10 A. M., nor after 5 P. M., except in special cases.

Rule 15.—All that is necessary for the comfortable support of the inmates of the Home will be furnished from the funds of the institution; no individual, therefore, will, on any account, be permitted to solicit assistance.

Rule 16.—All inmates are expected to render themselves generally useful, as far as their strength will admit.

Rule 17.—Smoking and the use of tobacco in any form is strictly prohibited, except in such place as designated by the Matron.

Rule 18.—The bell will be rung ten minutes before each meal, and all who are able will promptly repair to the dining-room. When seated, a suitable pause shall be observed. No inmate will be allowed to carry food from the table. The sick and infirm only will be accommodated with meals up stairs.

RULE 19.—No inmate will be permitted to interfere or find fault with Matron or assistants; but if they think they have cause for complaint they must apply to the Monthly Committee, who will receive their statement and take such action thereon as may be proper.

Rule 20.—To preserve harmony in the family the strictest attention should be paid to the rules of the Home. For the first and second offence, the Matron will admonish the offender. For the third, she will report them to the House Committee; and for the fourth, removal from the Home, if so approved by the Board of Managers.
