I think of you constantly and am looking forward to seeing you soon. Just now we are very busy getting the amendment ready to be launched- It will need a good deal of propoganda work I think: so many women are afraid it will interfere with laws protecting women's labor, and others are hoping it will, and we have to make it clear that it does neither- A woman is lunching with me to day for the purpose of discussing it. I am to see Mrs. Gifford Pinchoot this afternoon to tell her about it. The house is full- we only have eleven bed-rooms. Our state chairman from New Mexico is here- also from

Louisiana. Helen Todd from New York on some Russian relief business. A Mrs. Jenks from Rhode Island or something. Mrs. Johnson, the woman who "sculped" the statues- she says she's very busy, but I can't imagine what she is doing- she spends most of the day in her room clipping newspapers- I think she is preparing to write a book- and I'm wondering if she isn't just a little batty in the head.
