Modest Members Box opened. Poem read.

Mrs Turner. Had been asked about introducing the teaching of proof-reading, into the Guild.

Miss.Burmeister. Knows a lady Proof-Reader, who gets over ten dollars per week.

Miss. Jones. A woman will not get as much as a man.

Mrs Pond. It requires one well educated to fill such a position.

Miss. Miller. Is it healthful?

Mrs Pond. Thought it not necessary to be in the Printing Office all the time.

Mrs Turner. Said a class would be formed on any subject that six members would apply for, and thought it well to decide the matter at the next meeting.

Miss.Miller. Moved that the meetings be discontinued after July. Ist.

Miss. Jones. Thought it well, as there would not be enough to make it interesting; and it would be sad to come, and see so few and think of when the room was full.

Mrs Turner. Suggested that meetings and sociables be combined, for the summer months.

Miss. Mc'Intyre. Would like to have the vote taken,
that she might vote it down. Moved and seconded that
the next meeting be one month from this night.

Carried.

Mrs Turner. Opinions have not been given as freely as on previous occasions; she guessed they were afraid of the minutes.

Miss. Mc'Intyre. Said that could not apply to her, as she had already been called, "Secondary".

SAVING FUND.

Miss. Jones. Thought the idea of a Saving Fund very good, but breathlessly asked, who would take charge of the money?

Miss. Connelly. Thought Miss Jones. too anxious.

Mrs Turner. Mr.Gauthrop would willingly take charge of the money, and she thought it a grand idea, as she often put money away and tried to forget where it was, and then when she wanted it particularly, it came very acceptable.

Miss. Miller. S Seconded.

MINUTES OF THE N.C.W-W.G.

Jan'y 31st, 1885.

The first Annual Meeting of the N.C.W-W.G. was held Sat' eve' Jan'y 3I, I885.

Miss M.T.Lewis presiding, thirty-five members present.

The annual Report, showing in brief, some of the aims of the association, and the work accomplished during the year, was read by the President, Mrs E.S.-Turner, and accepted by the Meeting.

Mr. Gauthrop, Treasurer, reported the present membership of the Guild about IOO. - that he had rec'd since Jan'Ist, '85. \$41.50. which he had been authorized to pay over to the new Treasurer, should one be elected in accordance with the rules about to be acted upon.

Miss. Bell, Chairman of the Com' on Entertainment reported, that since Oct' last, her Committee had superintended three Social eve's- the first a talk form Mrs Brinton, on Palestine, Ill's by Souvenir's of Syria. During Christmas week, the dramatization of "Dickens' Cricket on the Hearth," was read in character by members of the Guild, and the Evening ended with music and social games.

At the last Social Meeting, Miss. Orum, with the assistance of some of her pupils, gave some very enjoyable recitations, and musical selections to a large audience. The Report of the Entertainment Com' was accepted.

Mrs Pond, Chairman of Com' on Hospitality reported, that the members of her Com' had tried faithfully to do their duty, that she thought no stranger had been allowed to go away unwelcomed, and, she thought that finally, under such influence, we should "all, become very agreable people." - Report accepted.

Miss. Jones, Chairman of Com' on Woman's work, made a very interesting Report, especially relating to the manner in which women employed in stores and manufactories are treated by their Employers, giving a list of those especially to be commended. Report accepted.

The Chairman of Com' on Country Board, Mrs Turner, reported that they had found cheap comfortable homes in the Country during the Summer, for several Guild Members. Report accepted.

Mrs Ganwthrop, Chairman of the Special Com' on
Library, gave detailed Report of the work of her Com'.

She reported 410. Books in the Library, (all of which had been presented.) exclusive of census reports

and Encyclopædia all of which have been Labled and Gatalogued. Fifty-nine members have availed themselves of the privelege of taking out books to the number of 703. Greatest number taken by any one member, 40. The Card System of Registration was commenced.

Attention was called to Vol's containing the last Census Report of the U.S. in which may be found many statistics of to Working-Women and, in closing, the Committee recommend that each member using the Library, should read at least, four books of history, biography, or natural science, during each year.

Report accepted.

There being no other reports, the Sec'y was requested to read, for the consideration of the meeting, the

"Rules for the Government of the New Century
Working-Woman's Guild." A few amendments were made,
the principle of which related to the holding the
Annual Meeting: then each Article as amended was read
and adopted separately.

The subject of printing the Rules was discussed, and Mrs Gauthrop moved that the printing of the Rules be left to the Executive Board; seconded and carried.

Mrs Gauthrop moved the adoption of the following

resolution, which was carried.

Whereas, The appointment of Carrol D.Wright.

as Commissioner of Labor, is one that should have the approval of all workers, and especially of Working
Women, it is therefore

Resolved. That the Executive Board, through its officers be requested to convey to Mr.Wright, the Congratulations of the New Century Working-Women's Guild of Phila' feeling assured that the careful and intelligent service he has rendered the Working Women of Boston, will now be devoted to the collection of industrial statistic's not only for Women, but for the whole People.

The Chairmen of the Standing Committees were appointed by the Chair, who decided that no better selection could be made than those already holding the positions.

After adding the name of Miss Crawford as Chairman of Library Com' it was moved and seconded that the Chair select the whole of the Committees, which was then done and names announced.

The motion to allow absent members to vote by proxy at this meeting was defeated.

The election of Treasurer being next in order,
the names of the candidates nominated at the last meeting were announced: Miss. Jennie Crawford, Miss. Esther
S Jones, Miss Estelle Burmeister, and Miss. CarenaWhitaker. The voting then proceeded by ballot, MissMc'Intyre & Mr. Gauthrop being chosen Tellers.

While the votes were being counted, Miss Lewis read a letter rec'd by Mrs Turner from Mrs Dodge of New York. The Tellers then announced the result of the vote as follows-

Defered business was then taken up;

Miss Jones, who had been requested to ascertain the cost of Guild Pin, gave \$1.50. as the price of a design from Bail&y Banks & Biddle. This was thought by some to be too expensive. Com' then discharged.

A motion- that the question of having a Woman-Physician at the Guild rooms for consultation be referred to the Executive Board, with approval of Guild, was carried. No preference was expressed for any particular school.

Reference was then made by Miss Lewis to a Sanitary Science Club of Boston, and it was suggested that it would be very pleasant to have some talks on Hygiene.

The resolution, embodying the opinion of the Guild with regard to accepting treats &c, was ordered to be read. Owing to the negligence of the Chairman of that Com', it was deferred until next meeting.

New Business.

A motion that the Guild subscribe to Century & Harper was carried.

It was decided, also, that all the books recommended by the Library Com' be bought, provided the Finance Com' say they have the money.

The Library Com' were requested to purchase the books.

The question of increasing the membership of the Guild was referred to the Finance Com'. The earnest attention of the members was also asked in this direction.

An article on "Wages of Working-Women" was read.

In Boston the average salery of working women is

\$5. per week.

It was suggested that the way of regulating the wages of women was to increase the number of occupations engaged in by them, and so reduce competition.

The necessity for trained labor was particularly dwelt upon.

It was further remarked that very many women ought to be able to find congenial employment in household service, and that particular attention should be paid to engaging refined women as child nurse.

It was ordered that the Com' on Entertainment select ten members, each to give at next meeting, a short account of some act of womanly heroism. After appointing E.Burmeister, president, and C.S.Mc'Intyre secretary of next meeting a motion to adjourn was carried.

November 27th, 1886.

The meeting was called to order by Miss Lewis, the President.

The minutes of the previous meeting were read by the Secretary, Mrs. Holman, and were approved.

The report of the Treasurer --- showed the receipts for the month to have been \$23.50 for membership dues, \$8.00 for Gymmasium fees and \$1.11 for Library fines; total receipts, \$32.61; expenditures, for amount of Gymnasium fees, received from March to September 30th, 1886, paid to H. Gawthrop, Treasurer of Executive Board, \$32.50; bill for program cards and envelopes, \$4.45; stamps, \$2.10; Entertainment Committee, \$20.00; postals and printing, \$6.25; total expenditures, \$65.30; leaving a balance of \$129.95 in the treasury; accepted.

Finance Committee --- reported bills of \$35.00 for books and \$4.70 for Bulletin Board; report accepted and Treasurer instructed to pay bills.

Entertainment Committee --- reported that on November 16th a musical and literary entertainment was given, which was well attended. They announced a series of tableaux for the next entertainment, December 18th; and also that it was the purpose of the Entertainment Committee to have a Christmas Social on December 29th, and on that occasion each member was requested to bring some small gift, not to exceed 15¢ in cost.

Library Committee --- reported 6 new books bought, and the donation of "How to Win" by Miss Willard, by Mrs. Gawthrop, and a number of books by Mrs. Margaret Lesley Brown. They also reported that "Bacon's Essays" and Education " by Herbert Spencer were in the Library. This report was accepted. The Committee requested that they be instructed as to the magazines to which they should subscribe for the coming year. Mrs. Gawthrop moved that we subscribe for "Harpers' Magazine" and "Bazar" and for the "Century" magazine; carried. The Committee also asked instruction as to whether they should have the old magazines bound; after some discussion as to cost, on

motion of Miss Jones, the Committee were instructed to have "Harpers' Magazine" and the "Centiry" bound.

Committee on Woman's Work --- reported statistics from Globe Printing House, Fairhill Fringe Works and Shirt Factory. Mrs. Turner made some remarks on the object of this Committee, and Mrs. Gawthrop asked some questions as to certain branches of inquiry, which it was decided would be well to pursue with a view to getting better accommodations for women in the buildings where they are employed.

Mrs. Gawthrop stated that she had found that in the mills around the Fairmount district, while the operatives were paid for overwork, those who were not willing
to work over-time were discharged. Miss Jones said that the reason for this was, the
e,ployers had a certain amount of work which must be done, and they depended on their
employees to be willing to do it; Mrs. Turner thought that a remedy for this could be
found if the proper method was used.

Gymnasium Committee --- reported that 4 paying day classes were in operation, and there was a prospect of another. The Monday class was well attended. They asked to be allowed to buy a thermometer for the Gumnasium, the instructor having requested one. The report was accepted, and the Chairman instructed to buy a thermometer and the Treasurer to pay the bill.

Friendly Visitors --- reported that they had made ll visits and that their name seemed an appropriate one. They also reported the resignation of Miss Lasser, on account of other duties; which resignation was accepted, -as was also the report.

Mrs. Gawthrop was then allowed by a suspension of the regular order of business, to present to the Guild a petition for the better protection of women, which the Department of Social Purity of the W.C.T. Union propose to bring before the legislature of the State. She explained the law on the protection of young girls, and requested that the Guild members should not only sign this petition themselves, but that they should use their efforts to have their friends sign it; the petition will be left in the Guild rooms for this purpose. Her remarks showed that the laws of this and

other States are absurdly inadequate, and that a strong effort is needed for their amendment.

Under deferred business, the questions of the amendments to the Constitution of the Guild, proposed at the last meeting, were taken up. In the Preamble to the Constitution it was proposed to substitute the words "Executive Board" for "Executive Committee;" adopted. In clause first it was proposed to change the present rule to the following: "The Chairman of the Executive Board shall be the President of the Guild, and the Guild shall elect from its own number, two Vice-Presidents, a Secretary and a Treasurer. One of the Vice Presidents shall be responsible for the order of each business meeting, and the Secretary shall be responsible for the minutes. The Treasurer shall keep accounts of all moneys received from membership fees and fines, and shall make payments only on orders passed at the stated meetings of the Guild. She shall make monthly reports to the stated meetings, and a review at the Annual Meeting;" this amendment was adopted.

The following changes were proposed in Article II; on membership, -in the first line to change the words "Business Committee" to "Executive Board;" in the second line to change the word "shall" to "may," and in the fifth line omit the words "on recommendation of three Guild members;" amendment adopted. In the article III on Meetings, it was proposed to insert in place of the word "Treasurer," "officer." On the third line to change "her" to "their" successors. Also to change the second clause of article III to "The stated business meetings shall be held at intervals of four weeks at 7.45 P.M.; the first to be held two weeks after the annual meeting;" adopted.

It was proposed to add to article IV, as standing committees, the Gymnasium and Friendly Visitors Committees; also to omit the Committee of Country Board as a standing committee, and make it a special committee; adopted.

A new clause was proposed as follows, - "Any public action must be submitted to the Executive Board;" adopted.

The meeting proceeded to the election of new members, and 22 were elected.

Gifts of a gas stove by Mrs. Jones, a sofa by Mrs. Esherick, were reported; and the Secretary was directed to write letters of thanks from the Guild to these ladies and to Mrs. Margaret Lesley Brown for her gift of books to the Library. The loan of a table by Mrs. Lewis was also reported, and the thanks of the Guild extended to that lady.

Mrs. Turner said that as the services of the janitress became more heavy with the enlargement of the work of the Guild and also its membership, she thought it just that the Guild should pay for this added trouble; she suggested \$5.00 as the proper amount per month, and moved that this sum be paid her from the Guild treasury; Miss Jones seconded the motion. Mrs. Gawthrop amended that it should be payable after the 1st of December; amendment accepted and the motion adopted.

Mrs. Turner spoke of the Audobon Society for the protection of song and other birds. Miss Lewis read a sketch from a paper on the subject of wearing feathers in the hat.

The attention of the Guild was called to the death of one of its members, Eleanor Newland. The Secretary was instructed to send a letter to Miss Newland's parents expressing the sympathy of the Guild, and its regret at losing her from among us.

An invitation to the Guild to attend a lecture before the Historical Society on the 29th inst. was read.

A letter was read from the Modest Members' Box referring to the trouble experienced by some of the members in not being able to speak, owing to the fact that some other of the members of the Guild monopolized the floor. It was moved and adopted that no member hereafter be allowed to speak on the same subject a second time until it was certain that no other member wished to speak. It was suggested that in order to avoid the solemn silence which generally fell on the meetings when these members were not speaking, the President call for expressions of opinion from those who

are generally deprived of the opportunity of expressing themselves.

mrs. Turner spoke of dangerous amusements; she said that in some dancing acade emies or classes it was customary to admit any man who would pay the small sum of 15¢, and in this way the young girls attending such classes were exposed to the tem-ptation of making acquaintances which were undesirable and which would not be made in any other and more legitimate way; that in some cases so-called "society men" made a practice of visiting such places to find victims for their amusements. She spoke of the necessity of all places where this was possible being avoided. A lively discussion followed on this subject: it seemed to be the opinion that no Guild member would be exposed to such temptations, although others might. Miss Burmeister, however, confessed that she had attended dancing classes, presumably one of this kind, but that she had not found it at all alluring. This, possibly, may have been on account of her being a Guild member, and possibly because none but a little old man asked her to dance. It was generally considered, nevertheless, that girls must dance and hafe a good time, and it was suggested that we as a Guild, do all in our power to prevent anyone from attending such classes; but that we also try to find some substitute for such.

Miss Jones spoke of the desire that a "Once a Day Club" be formed in the Guild, the members of which would pledge themselves to perform some kind act, whether by word or deed, every day. Miss Connelly said that the suggestion made at a previous meeting, that refraining from speaking against others when opportunity offered, was a kind deed, had struck her forcibly as a very good one, and one which she had put in operation with satisfactory results to her own happiness. The idea seemed to be agreeable to the Guild, and Mrs. Gawthrop suggested that a book for the names of those who wished to join this Clyb might be placed in the Library, and that the members could meet when they chose to discuss their intentions and progress.

Mrs. Turner suggested the propriety of the Guild members refraining from in any way disparaging our work, or our workers.

No further business being before the meeting, it adjourned at 10 o'clock.

Mrs. Turner then explained the object of the Friendly Visitors and the Committee on Women's Work, stating that the Friendly Visitors were just what their name specified and had no beneficial object in view in making their calls.

The Committee of Women's Work had for its object the gathering of information concerning all places where women are employed, to be placed on file, for use and examination, only of Guild members, in case of a desire to change employment.

The following persons were elected as Guild members, having been duly recommended and their nominations sanctioned by the Executive Board;

Marie E. Gillis; Mary E. Pavey, Nettie L. Jennison, Mamie M. Hinchman; R. H. Carpenter, Dollie Riedel; Grace E. Jennison; Lizzie Kees; Mary Smith; Frank B. Skinner.

Mrs. Skinner brought before the meeting, the importance of providing the chairman of each Committee with a certain number of postal cards, that she may notify her Committee and call them together at any time; also that the Treasurer have a supply of

and stamps. On motion of Miss Lewis, the meeting decided that the Treasurer should be empowered to spend \$5.00 in postage stamps, cards and envelopes; the bill to be approved by the Finance Committee, whose business it should be to see that the postal cards are properly distributed. This action was deemed necessary, in order to facilitiate the works of the Committees, and to enable the Treasurer to dispose of her membership cards, to those parties to whom it was not possible for her to hand them at the meetings.

Miss Anthony not being able to serve as Chairman of the Hospitality Committee, Miss Burmeister was duly appointed to take her place.

The special Committee appointed to look after the printing of the rules and regulations, advised the meeting that it had been suggested as a wise proceeding, by an outside party, to have the names of the Guild members, attached to these rules and regulations; this being the custom in many organizations.

Opposition; - first, on account of the cost, as if attached to these rules and regulations, they would be utterly useless for distribution after the first year, as the members necessarily change; old ones going and new ones coming in. This was obviated by the suggestions of Mrs. Turner, that the names could be printed separately. Miss Whitaker rose to ask what would be the advantage of having the names printed and as this was just what the Committee wanted to know, we waited to be enlightened. There seemed to be no real advantage, except that it seemed a "nice" thing to do and met with the approval of the majority of the

members. A rising vote was called for on this question; 29 being in favor of having the names printed on a separate list from the rules and regulations and 9 who objected to having the list printed. Thus the motion was carried and the list ordered printed.

We were glad to listen to Mrs. Gawthrop, when she informed us of an act, which has just been introduced by a member from Pittsburg into the Legislature at Harrisburg, providing for seats for female employees in all manufacturing, mercantile and mechanical establishments; with a second section, imposing a fine of \$50. or imprisonment upon any person, not conforming with this act. It has passed the House; not a person voting against it and is now in the Senate.

The wonder that but few women had entered the lists of Trained Nurses was then commented upon by Mrs. Turner, who related an incident of how Dr. Mitchell went to the Nurses' Directory, not long ago and there was not a single one disengaged. The fact that this vocation is not nearly filled; that it pays well, would seem to recommend it, and suggested that there must be members of our Society who could fill these positions with credit. The various Training Schools in the city were then alluded to by Miss Wilbur; those attached to Blockley, Pennsylvania and Women's College offering Special advantages and a small stipend per month to those students entering for the full term of two years.

A discussion then followed, as to the capabilities of women in contradistinction to men, as clerks; called forth by an

article written by a Princeton professor and printed in the "Forum". Well, there was nothing new in this attack, and we came to the conclusion that there was nothing else to do, but live down the objections, by the fruit of our lives.

The Once A Day Club was then referred to; its object explained and some suggestions as to kindly deeds followed. An earnest member wanted a reminder. Miss bewis suggested the idea of putting something in the Looking Glass, but as a man beholdeth his natural face in the glass and goeth his way, and straightway forgetteth what manner of man he was, this proposition was not deemed feasible, and a suggestion then followed, as to a badge of ribbon, but as this soils quickly it did not seem to meet the requirements. Miss Garrdson, then spoke of consecrating one of our regular scarf pins, but this idea also was discarded and the meeting unanimously appointed Mrs. Turner to look into the matter of securing a Pin for the Once A Day Club, to be used as a reminder to help each other.

The meeting then adjourned.

matter of interest to us, as the success of the classes here, did much to encourage their formation, and coming under the same category should be placed the fact referred to by Mrs. Skinner, that there has been formed in Boston, a Guild very similar to our own, whose leaders had applied for our Rules & Regulations, wishing to establish one, taking ours as a model.

On motion of Mrs. Turner, it was unanimously decided to send a telegram of good cheer to the Working Women's Societies of New York, who were to hold their 3rd Annual meeting on the I4th inst. A greeting from our organization having already been forwarded.

Miss Haydock being present favored us with an account of her experience as a trained nurse, expressing her unbounded faith in its possibilities as to recompense, and as opening up many opportunities for doing loving service for others at the same time. The other side of the question was agitated by Miss Devidson, who spoke not so hopeful as to the possibilities, alluding to the extreme confinement, self abnegation and strong physical force requisite. This was not surprising as there are always two sides to every question.

"Should a woman in choosing her occupation, do what she finds she can do best, or what is considered feminine, and if the latter, whose opinion, or what principle shall be the standard?"

This, - the subject for discussion : and although no formal conclusion was arrived at, during the progress of the discussion, three distinct ideas were advanced, according to the bent of the several members; one of these venturing the remark, that in her opinion, the Creator never intended woman to earn her own living. A small minority was represented of those who were willing to follow in the footsteps of their foremothers, considering sewing and keeping house, distinctively her proper sphere, and that to step out of this would disorganize society. The third and crowning idea, which we are glad to record represented the views of the majority present, amounted virtually to this :that she should choose for her occupation, that which she could do best, and seemed to have a special fitness for; no matter whe ther any woman before had ever attempted it. To be sure this would be hard on the pioneers, but pioneers were always a necessity, and in thus striking out in a new direction, she would be doing a good work, not only for herself, but for all her sisters. During the progress of this discussion,

rather the exception than the rule for a woman to really choose her vocation; simply drifting into store or factory, either through dire necessity, want of thought, or not knowing the way; thus, becoming fully alive to the importance of women's choosing their life work, carefully and discreetly, feeling assured that in the end, the world will be the better for the greater exercise of women's faculties.

She also touched upon cultivating our faculties in any special direction, mentioning the study of pictures, and if a number of members were interested, she had no doubt some of our artist members would help us. Visit the Academy of Fine Arts; go over the pictures with us, telling us what to admire and what not to admire.

Miss Lewis had in her possession, and which she referred to, just here, a paper, recommending to the members of the Guild, the study of our Civil Government, with a brief outline, as to the proper way of pursuing this study. Judge Wayland later on in the evening, expressed his hearty approval of women's taking up

such a course of study, as whether women vote or do not vote, they should have an opinion and intelligent appreciation of how we are governed, and a knowledge of the current political topics of the day.

No other business or suggestions coming before the meeting, Dr. Wayland was introduced by our presiding officer, who came with us, especially to talk of Sister Dora, giving us a brief sketch of her life, telling us of her passion for nursing, her indomitable will, her utter forgetfulness of self, her strong physical force, tireless energy and devotion to the welfare of others.

At the close a vote of thanks was sincerely tendered to him.

Judge Wayland followed with a few remarks, gratifying to our sex, and most of all endorsing women in the
capacity of trained nurses.

This lady objected, explaining that it was exceedingly difficult to get the names, and that she felt confident the attendance marked in this way could not be accurate. After some discussion of the subject, it was concluded that Miss Burmeister should mark the attendance for the evening, and a motion made, that at future meetings the Roll should be called, without comment. Subject for discussion, "Is there such a thing as "a white lie"? Affirmative side, Mrs. Gallagher;
Negative Side; Miss Read.

It is the duty of the Secretary to report that the representatives in favor of white lieing were in the ascendancy. Mrs. Gallagher, as upholding her side, and for the sake of the argument, although not wishing to put herself on record, as being in favor of the practice

of lieing, created an impression not from any facts or truths which she set forth, but because she worked on the feelings and emotions of those present by relating anecdotes, chiefly from fiction, showing how good had been accomplished by withholding the truth, and giving a false impression. Miss Read differed with her, giving us the etymology and grammatical definition of the word. Miss Garrison made decidedly the best hit in favor of the whole truth and nothing but the truth when she remarked that the argument against white lieing was put on too low a plane, saying that the Commandment was very plain, "Thou shalt not bear false witness". Mr. Gawthrop helped the side of truth, suggesting at the same time that tact should be used, so as not to offend. A few other members also lifted up their voices on the side of truth and right. In order to sum up the general opinion of the meeting, the question was changed to "Are white lies ever justifia ble." A rising vote was taken, the majority being in favor of white lieing, although a goodly number held to the opinion that a lie is always wrong, and under no circumstances justifiable.
