the meeting, a letter which she had received from Mrs.

Turner in reference to fixing up the front yard, with

advised us, that after all the bills were paid, there
would be a balance in the treasury of but \$24.20, the
conclusion was arrived at, that it would be unwise to
attempt to do anything more than keep the grass in good
condition. An additional reason being urged that the
tearing down across the way would keep the street,
generally in a bad condition, and the dust and dirt
would prevent the flowers from growing. A motion was
carried to advise Mrs. Turner to this effect.

The Roll was duly called by Miss Burmeister, during a pause in this discussion and before the question was fully decided.

Miss Lewis called the attention of the meeting to Mayor Fitler's course of action, in endeavoring to suppress the dens of impurity throughout the city, and it was decided that the Guild send a letter of thanks expressing appreciation of the Work of Mayor Fitler and his associates.

Mrs. Gawthrop then told us that a petition, which she asked the members of the Guild to sign some four months back, appealing the Legislature, to raise the age of consent from ten to sixteen years had passed the Legislature, and had been approved by the Governor, and that this Act had now become a law.

SUBJECT FOR DISCUSSION,

"Resolved shall the American Woman vote."

To properly bring this question before the meeting.

Mrs. Gawthrop made a motion, resolving that the

American Woman should vote.

Fearing lest we should all be of one mind on the question, Mrs. Holman armed herself with the opposing arguments of Prof. Cope, and read for our benefit, his article against Women's Suffrage, in the "Naturalist". A short silence followed, and then the advocates of

Women's Suffrage came to the front. All the best reasons for Women's Suffrage were advanced; one member only expressing her opposition, which seemed of the kind that could easily be argued away. Interest was added to the discussion by the presence of Mrs. Lucretia Mitchell and Mrs. Josephine B. Justice, two active members of the Pennsylvania Women's Suffrage Association, who gave their testimony, as to the necessity and right of women's voting, and distributed among the members, a number of tracts on the subject, which they said carried greater force in their arguments than anything that could be said by them. A vote was called for, and the members all expressed themselves as being in favor of Women's Suffrage. The negative side of the question receiving no response.

Mrs. Gawthrop advised the meeting that Mrs.

Skinner had informed her that all the membership and application cards had been used. The meeting appointed Mrs. Gawthrop, Chairman, to select a committee to see that a further supply of these cards were printed.

As this meeting closed the season before the summer, it was decided that the date of the first one to be held in the Fall, should be determined by the presiding officers and the chairmen of committees.

A letter from Mrs. Turner who was unable to be present at this meeting was then read, touching upon enlarging our membership, advising that each present member should make herself responsible for bringing in one new person, saying truly, the larger a society, if well managed, the more it can do, and pointed to the day when we hoped to be a real power in Philadelphia She also in this letter touched upon the fact, that by organization, we could do much to raise the status of working women, and this without putting ourselves in antagonism with employers; suggesting to the Committee on Statistics of Women's Work, the gathering together of all the good things that employers were doing for their female employees.

upon motion of Mrs. Holman a Committee was appointed to be called, a Committee on Education or Mental Improvement to consider the subject of providing during the winet r, some mode of mental culture; either in the way of getting up lectures on scientific or literary subjects, or to form clubs for taking up some work of interest to the members. Mrs. Panzerbieter gave her hearty endorsement to this movement, saying she had long wished for such an arrangement. Miss Burmeister also endorsed it. The committee appointed, consisted of Mrs. Holman, (Chairman), Mrs. Gallagher, Miss Burmeister Miss Abel and Miss Reed, and upon the request of Mrs. Holman the committee was given power to add to its members, if so desired.

Miss Heim again brought the subject of binding the back numbers of the magazines be fore the meeting. As heretofore the subject was left entirely to the discretion of the Library Committee.

Mrs. Holman asked that between this and the next business meeting, the members deposit in the modest member's box, subjects for discussion, to be entered into at our regulat business meetings; a choice of eight or nine could then be made, to be taken up, one each evening. This plan, she felt sure would add to the general interest of our meetings.

Miss Whitaker asked the members to think about the subject of a building fund, stating that in her

opinion, we had moved around about enough. She recognized the fact that it would take a good many years to get a building fund, but that we had better start to get it at once. Mr. Gawthrop added his judgment to this matter, saying that in all probability, the subject would come up before the next meeting of the Executive Board, and the plan would probably take the shape of the A. B. C arrangement, when each member of the Guild would have an opportunity to help. Miss Whitaker suggested that it would be well not to confine ourselves to any one way of raising money; she also stated that in fact, the ball had been set in motion, a number of members having already pledged themselves to give. \$1.00, each.

Mrs. Florence Kelly Wischnewetsky, who heads
the list of members, and who with Mrs. Turner and Miss
Clements, in '82 were the pioneers of this Guild was
introduced by Mr. Gawthrop. She spoke of her pleasure
and delight in coming back after an absence of four
or five years and finding the Guild so fully grown and
so fully fledged; she spoke of her ideas in those days;
of having the Evening Classes teach to the girls, some—
thing practical, by which they could earn money, and
that these Evening Classes might act as an entering
wedge and force something better into the ways of the
night schools, which were conducted by the public. She
had hoped that the Guild might be a nucleus for gathering

of working men and women in the same lines of work; exactly what the difference is between the wages ofwomen and of men, and exactly how much women are to blame for the falling off of men's wages.

A sentence in Mrs. Turner's letter to this effect;

"When the Knights of Labor range themselves on the side

"of Law and Order by refusing to side with the

"condemned Anarchists, what a weight it carries,"

called forth from this lady an earnest expression of

opinion, that not wishing the Anarchists hanged, cer
tainly did not mean that one approved of their methods.

It seemed to her mind, a pity that sixty million people

could not manage seven men who had done wrong, without

hanging them, and she closed her talk with this protest

against the system of hanging.

After Mrs. Wischnewetsky's talk, the discussion as to the Building Fund was continued, and Miss Whitaker was appointed Chairman of a Committee, with power to choose its members, to cooperate with the Executive Board in order to inaugurate a Building Fund.

The meeting then adjourned.

during the month that had past four calls, (three visits to the sick and one visit to a member whom the Committee thought needed a little bit of encouragement) and had sent out one bouquet. She also advised that Miss Niles wished to resign from this Committee, and asked if this resignation was accepted that Miss Longwell be appointed in her place. This was so ordered. She also asked that the allowance which had been given to her Committee last year for flowers be renewed this year. The treasurer's funds being so low, there was some unwillingness to comply with her request when Miss Garrison stepped into the breach and suggested that each member give one cent for

this purpose. This proposition was received with much willingness, and a collection being at once taken up \$3. was realized.

GYMNASIUM COMMITTEE, (Miss Alterus) Mr. Gawthrop acted as spokesman for this Committee, stating that he could give no definite information but hoped that the Gymnasium would be opened by the first of November; that members who wished to join should register their names, and that the terms would be stated as soon as possible..

LIBRARY COMMITTEE, (Miss Heim) reported the purchasing of the following books,

the Committee from the Executive Board had decided to have Collection Cards printed; each card representing, \$1.00 and that Miss Bell had been selected Treasurer to receive all the money collected; her election having been confirmed by both Committees. Later on in the evening Mr. Gawthrop went more into details in regard to the character of these cards, saying that the Committee had thought best to give up the A.B.C. scheme, as being too complicated and involving trouble and confusion and had adopted this card system instead. There were ten minus marks on each card, which upon the payment of ten cents

could be converted by a stroke into plus marks. Larger sums could be paid direct to Miss Bell, the Treasurer; at whose option the money would be placed either in the Western Saving Fund Society, or the Real Estate Title & Trust Co., and when it had reached a sufficiently large amount would be invested to bring in an income. Miss Bell announced that \$8.10 had already been entrusted to her as a nucleus for the building fund.

Miss Whitaker further advised that the Collection Cards could be obtained from Miss Wilbur, and that it had been suggested to hold a Fair in the Spring to raise money for the Fund.

Mrs. Holman, as Chairman for the Committee on
Mental Improvement read her report, and outlined a
plan to be carried out under the direction of her

Mrs. Holman referred to the unreliability of the present mode of marking the Roll, and as it took eight minutes to call and in the end did not give the full number of members present asked if some other could not be adopted, and upon motion of Mr. Gawthrop it was decided to refer the matter to the Hospitality Committee, who are to report some better method of marking the attendance.

A long discussion followed as to the advisability of holding a Fair; the reasons for and against it; the worry, annoyance, wear and tear involved to those who take the responsibility; the fun which is always to be gotten out of such work; the opportunity which would be given the Guild to show what valuable work could be produced by its members in the industrial line : the fact that a Fair seemed like putting money into something and then drawing it out again : that people who would not give money to the Fund would attend the Fair and buy something which perhaps they did not care to have, and that this weakness of human must be taken into consideration. All these points were discussed at length, and as the majority of the members present signified their willingness to stand by the Committee, to do all in their power to make the Fair a success the matter was referred to the Committee on Building Fund to be carried out, and members were asked to send in writing to the Committee, suggestions containing original ideas, as to the name, outline of work, arrangements, etc.

Mrs. Holman asked that a Committee be appointed whose object would be to try and improve the conditions of Working Women; to raise the standard, to right grievances, to try and improve the sanitary conditions of the places in which they worked and to see if something could not be done to prevent women from working over time and to suggest to women to take up better means of obtaining a livelihood than the most of them pursue now. This seemed to most of the members, really the object for which the (wild was started and for which it was now carried on. Mrs. Holman then wished to know if there was any special Committee who would attend to work of this kind, or who could be applied to with grievances or for information. Miss Lewis then referred to the Legal Protection Committee for Working Women under the auspices of the New Century Club, which made investigations and in many cases righted the wrongs which had been inflicted by employers, and remarked that it would seem a pity for us to undertake what somebody else was doing well. To form a Committee

of this kind seemed to one of the members like saying that the Society for the Prevention of Cruelty to Animals had formed a Committee to prevent animals from being cruelly treated. Mrs. Turner suggested that perhaps the wisest way to go about this work and certainly the only way not to antagonize employers was to have a branch of the Committee of Statistics of Employment in unison with the Committee appointed from the Executive Board , inquire into all the good things, all the points of consideration for employees on the part of employers; to ask employers themselves and with their consent publish these good reports; to thank them for common justice in regard to accommodations, sanitary arrangements, etc. since so many employers were not just, and stated in conclusion that the very fact that these good points were noticed and commented upon would make public opinion on these questions and doing that be productive of good ..

Mrs. Holman further explained her views.

She thought some special Committee ought to be appointed to act as confidential advisor, to whom Guild members could apply with their grievances, who could talk over matters with employers and see if influence could not be brought to bear to have the grievances righted. Mrs.

Mumford asked that her Committee from the Executive Board which is to work with the Committee of Statisics, be given a chance to show what they could accomplish, and upon motion it was decided to postpone the question

for the present.

Mrs. Phillip asked that a Committee be appoint ed to collect and arrange pictures, worsted, scraps of ribbon, silk, etc. to be distributed among the children and convalescents in hospitals, with Miss Garrison, as its Chairman, with power to appoint her own Committee. This met with the hearty approval of the members and her wishes were carried out. The Committee selected by Miss Garrison consists of the Misses Ringwalt, Turner, Sallie Haydock, Wilbur, Price, Burmeister and Mrs. Phillip, with power to be added to if desired.

On motion of Mrs. Gawthrop a vote of thanks was tendered to the Mental Improvement Committee for its active work in getting up the series of lectures and various circles.

Mfs. Turner stated that as the result of a discussion which had taken place at one of the Guild's business meetings, a number of applications for good house servants had been received from people willing to comply with the conditions and requirements which had then been laid out, but that no good help of this character was available, and suggested that perhaps girls would be willing to go out to domestic service, returning to their homes in the evening, the same as they pursued other occupations.

On motion of Mrs. Skinner a vote of thanks was tendered Craig, Finley & Co. for their kind-

ness in printing the monthly notice cards of the Guild, without cost.

Mrs. Gawthrop advised the meeting that there was in prospect a little paper, having for its object Guild matters, and wished to know how many members would be willing to pay a small subscription of ten or twenty cents a year for its support; whereupon the members signified their willingness by raising their hands. The meeting then adjourned.

The Annual Business Meeting of the New Century Guild of Working Women was held January 28th, 1888.

Mrs Turner the President, in the Chair. E. Burmeister acted Secretary.

The minutes of the last Annual meeting held January 29 were read and approved.

Mrs. Rurner made a few remarks as follows: -

" To begin with self-congrabulation. We are a growing Society. To-day our numbers are larger than ever before. and there has never been shown so active and general an interest as this winter. Morever, we are becoming better known, and consequeently our outside influence is greater. To say now-adays, "I am a member of the New Century Guild of Working Women," con fers on the speaker a certain dignity with the constantly increasing number who understand what it means. And we may justly rejoice not only on what we have done for ourselves, but what our example has done in starting other associations after our pattern. What we have learned for ourselves, by working together, has been most valuable. The directions in which we have something still to learn should also be considered.

First: We learn in co-operation to endure opposit on with serenity, and if needs must, to accept defeat without resentment; to fight to the death, for our own way of managing, and then, if out-voted, whether in a committee of three or a meeting of three hundred, to turn square round, unless in a case of conscience, and use our best efforts to support the winning side.

Second: To strive with all our might, in all our doings together to rise above personalities. This is hard work for us all, but the higher we aim, the higher we shall be able to keep. The third hard lesson to fully learn is to respect obligations. While acknowledging the increased activity of the past year's committee work, we hope we shall not appall those who are to follow by this assertion. To assume any position in an association is to assume a trust. It means, or should mean, a sense of personal responsibility. In such a society as ours, whose members have so little time to call their own, there must often be justifiable breaks in attendance; but whenever a member, and especially a chairman of a committee, fails to keep her engagement because she forgot all about it, or didn't feel like it, or thought there would be plenty without her, she has not been long enough in her Guild to learn its meaning.

Third: This Society will never achieve its fullest possible success until every member, down to the youngest, feels that it is her own Society, and that she, as much as any one, is responsible for making it what she thinks it ought to be. On this princi-

ple nothing would so help us all as for every member to come straight out and say what she thinks she could do to promote the general welfare; what committees she would like to serve on; what new thing she would like to start; what old plan she sees a way to improve; or, if she is unaccustomed to speak, she could slip a note in the Modest Member's box; or, if she thinks she is worth nothing at all in any direction, she could at least suggest the qualifications of her friends.

We constantly feel that there is energy and faculty in the Guild unused, because we do not know where it is, and no one can do a greater service than to point it out.

The discussion on the subject whether "eight or nine hours work per day is most profitable, both to the worker and the one employed" was opened by reading several communications from business men, an article written by Miss Jones and two anonymous communications; following these, remarks were made by Mrs. Holman, Mrs. Turner, Miss Burmeister, Miss Jones, Miss Garrison, Mr. Ames, Dr. Wayland, Mr. Lewis, Mr. Howell and Mr. Durham; also by Mrs. Mumford.

In favor of the longer time it was urged that curtailed time would occasion need for more labor, and hence, through the added expense of such hire, the result would be disastrous to the employer; competition is so close that every item must be watched, and unless the movement were general it would be ruinous for a few to attempt such a course; that, with the exception of those who sought higher culture and intellectual amusement, the longer time was really best for the working classes, keeping them, as it were, out of mischief. Especially in trades connected with machine

the interest of the machine shop to run as much as possible, as by this way, more than any other, expenses are equalized and profit made possible. It was also stated that the public required a certain amount of service, which the new order of things would not permit; for instance, stores were required, by custom at least, to be open for business 10 hours per day; and, most important, it is thought that a reduction of time means a reduction of wages, as both go hand in hand.

on the other side, the need of rest felt by the workers was presented; leisure and a proper understand of what was to be done with this leisure; that it was not merely a question that concerned women only, but that men should be on the same plane; that the statement that women needed more issi leisure than men would act against them in their struggles to obtain equal compensation for equal work; the fact of the proverbial endurance of women would refute any statement that the agitation of this question was to be in the interests of women alone; to achieve success and not lose any ground gained on other points, there must be one broad platform on this also. The most important work is done in less time than the comparatively trivial; and we find this principle throughout. Then again, the rest and renewed vigor that an extra hour will give an employee would repay the employer for whatever

be avoided, in a measure, and the whole character of work done by a person who has had the proper amount of relaxation in the intervals would be superior. As to the public requiring attention for such a length of time, a determined move on the part of those who influenced the mind at large would soon impress the said public with the sense of the arrangement and induce those who required such long-drawn-out attention to be contented with the same in a shorter space of time.

It was predicted that no material improvement in this regard could be brought about until there was a change in public opinion, - a revolution of sentiment. Another advised organization, and another decided that legislation alone will provide the means of a general system of shorter hours. It was stated that unless one be in an independent position, and able to command his terms, employers may continue to make their own terms and find plenty to accept them, - scarcity of labor (this applying to men and women) will do most to secure proper terms, and place the matter of time and wages in the control of the workers.

Contents of the "Modest Members' Box:"

A communication was read asking what chance of success there was of establishing a paying business in darning, patching, etc. It was stated that this venture had not been a success at the Guild, and judging by the experience of those having the matter in charge, the chances of a private enterprise of this nature were not very promising; at least, it would mean patient and untiring work.

Another communication asked information regarding the general salaries of saleswomen in large establishments; also whether the positions were permanent to a competent person. Some of the members present, who understood the matter referred to, stated, without exception, that the salaries were very fair, and that the tendency seemed to be in the direction of increase; that a person who was willing and anxious to advance would be properly compensated; and that a competent person was reasonably sure of permanent

employment; generally, few changes were made in the large stores; and, altogether, the prospects of the saleswoman was bright. After some general remarks on the subject, it was moved, seconded and passed that the writer of these questions be referred to the Statistics of Women's Work on file and to these minutes. An expression of opinion regarding the advisability of continuing the "Journal of Woman's Work" was asked; the members freely expressed their appreciation of the Journal and their earnest desire that it should continue. On motion it was unanimously resolved that the publication of the Journal should be continued; it was also resolved, on motion, that the members would try to obtain as many subscribers as possible. It was stated that the subscription price of the Journal would hereafter be 25¢, instead of 20¢ as formerly. On motion, the meeting adjourned. I. E. Turner, Secretary . It was then moved, seconded and passed that an explanatory note should be added to the minutes of November 17th to the effect that the paragraph on mending, etc., refers to office work only, the finding of employment for women to go out to mend by the day having been much more successful; passed.

The 'Willing Hands' have offered to take charge of our next entertainment, on the evening of December 29th. The early part of the evening will be devoted to a Christmas entertainment for poor children; afterwards, music and dancing for Guild members and their friends.

The time draws near for our entertainment at Mr. Heppe's piano ware rooms, 1117 Chestnut St., on Tuesday, December 18th, 1888. The tickets are not being disposed of so rapidly as we wish, and we request that an earnest effort be made to dispose of the balance of the tickets before the evening of the entertainment. We would like to have a card in Mr. Heppe's window, and desire a motion to that effect."

'Magazine' and 'Century,' and have been receiving 'Lippincott's' and a number of other publications gratis. The Committee think it a waste to take the 'Nation' again; it is a

paper that has not been taken out much, and it has been read
very little. We have already subscribed for the 'Harper's

Bazar' and 'Magazine,' together with the 'Century,' having
been obliged to act at once regarding them. The question has
been asked why we do not take 'The Popular Science Monthly,'
and we desire instructions regarding this paper and the 'Ladies' Home Journal."

It was moved, seconded and carried that the Guild subscribe for the "Ladies' Home Journal" for 1889.

A motion to subscribe for the "Popular Science Monthly" was

presented, but upon the offer of Miss Hallam to give the Guild her copy after she had read it, this motion was withdrawn, and a motion to accept Miss Hallam's offer of the publication for one year was seconded and carried.

HOSPITALITY Committee (Miss Meuh) reported the attendance of 38 members and a number of visitors at the meeting of November 17th.

It was moved and seconded that the attendance at all the meetings, including the socials, be recorded; passed.

GYMNASIMUM Committee (Miss Piggott) An examination for the 18th was announced, and those Guild members who wished to avail themselves of the advantage that the Gymnasium afforded were requested to leave their name with Miss Wilbur.

MENTAL IMPROVEMENT (Mrs. Holman) No report.

FRIENDLY VISITORS (Miss Haydock) reported having made two visits and written one letter.

BUILDING FUND (Miss Whitaker) reported \$84.34 as the proceeds of the sale of December 8th; and stated that there some few articles to be disposed of.

WILLING HANDS (Mrs. Phillippe) stated that 4 pairs of shoes had been received, and about 130 pieces of wearing apparel, of which about 100 had been given away. One ulster and one dress in particular should be mentioned. A large box, containing books, silk pieces and zephyrs, had been sent to Dr. Bennett at Norristown. One—half ton of coal had been sent out, also 3 baskets of provisions. 15 visits, with sick diets,

had been paid. One position obtained for a girl of 12 years. 7 parcels of books and magazines had been received to be sent as soon as possible to the miners; also 6 packages of picture cards. 4 dozen mittens, 2 dozen picture books, and 2 do zen dolls and toys had been received for the Christmas entertainment to be held on the 29th.

Some remarks were made about the miner boys to whom the books were to be sent, and the Committee expressed willingness to forward to these deserving children, for Christmas, such papers as would be instructive and enjoyable.

In reference to the change in the name of the "Journal of Woman's Work," the statement was made that the term "Working Woman's Journal" was rather more distinctive; the intention is to have our paper speak for itself as a journal in the interest of working women.

members endeavor to obtain new subscribers; each one ought to
do her best to get one or more subscribers. It was also requested that advertisements be sent to the paper; the following

Mrs. Turner opened the discussion on "Trade Schools" with a statement to the following effect:-

The gift of I:V. Williamson to form a school for the technical instruction of boys has suggested the idea that something in the same line might be done for women. The effort was made to have Mr. Williamson extend the same advantages to girls, but he refused, saying that women should be taught at home, forgetting that they cannot. At present it is almost impossible for women to get any practical system or theory regarding even millinery, dress-making and cooking. The plan of making a general appeal has been proposed, and at the New Century Club it has been thought that if the influence of a good many women can be brought to bear in the right direction, it will have some effect. The members of this Club think that by combining with the Guild and its classes (making 1,000 persons at least), such an appeal will have weight with Philadelphians. It is now proposed that there be some action taken on the part of the Guild together with the appointment of a committee to co-operate with the Club in regard to it; the intention being to have pressure brought to bear, through the public, upon such men and women as want to make good use of their money. The idea would be to have a school where girls can learn their trade and learn it well, paying for their

instruction in work, or paying for it in money if they can afford to do so, but everything to be made as easy as possible. There are many who cannot afford to go and spend a year in learning a trade, and it seems perfectly legitimate, and not inconsistent with one's sense of independence, to accept such help as she absolutely needs.

Women's trades should not be restricted to dressmaking, millinery and cooking. Cabinet work should be done by women, also inside house painting. Everything that opens a new avenue of employment takes away a few from that terrible mass of sewing women, who are always clamoring for work that is not wanted, as work must be where the supply is in excess of the demand; whener we show a new way, we help the community.

If a girl goes to learn dressmaking, they keep her working a year or so making button-holes, and if she wants to learn
cutting and fitting she has to learn by peeps into the jealcusly guarded fitting room; she is obliged to spend all of
this wasted time in learning what she ought to have learned
in six months.

Miss Cameron: - As for fitting, one is obliged to pay \$10. or \$20. to learn it; after that, gain experience, and rely upon one's judgment. I think such a school would be a good thing.

Mrs. Gallagher: - I have a woman in mind who at one time was a nurse. Like many other women she would paper her own room; she was requested to do some papering for friends, and the consequence is that she has now a large trade and makes a

very excellent living.

Miss Ringwalt: - I know a woman who puts in her own glass, not depending upon the glazier. And if women can do these things so well occasionally, they would have every hope of success if they were given a fair chance.

Miss Bergen: - Some years ago there was a little book is sued, containing a number of suggestions in regard to occupations for women; someone had gone into factories and collected statistics of the women employed, the amount of wages given, and the effect on health. I also noticed that the Horticultural Association had a discussion recently as to the efficiency of women as florists; as an objection it was stated that there was a good deal of heavy lifting required in the business; but still I do not see why they would not employ gardeners under them to do the heavy lifting. It seems that the cultivation of flowers and small fruits would be very suitable to women, - also forestry.

Mr. Gawthrop: - I think the idea is not so much, in the proposed school, to teach technical trades, but the general idea is to perfect the boys, so that they will be able to take up any trade quickly; and that ought to be the case with women. The fact is, men do not have a full chance to go out equipped for labor, and I think that women have not half a chance.

Women occupy subordinate positions, it is possible, from want of technical education; if women are to take the place of superintendents and leaders in any place of

business, they must have proper education for it. The general remarks showed that the Guild was thoroughly in favor of making a strong effort to effect the desired results, and upon motion it was RESOLVED that the officers of the Guild forma co-operative committee with the New Century Club concerning this mat ter of Trade Schools. The question "What can we do to make these meetings more interesting," was discussed, and the general sentiment of the members present was that the meetings could be made more attractive by having a subject for discussion that would be of real interest to all. It was also thought that if the members would invite their friends to the business meetings, they would be larger and more interesting; one member stated that, by issuing invitations to those who were not members, the desired effect might be reached, as had been the case with other societies.

The main discussion for the evening was "How can cliques in our Guild be avoided, and is it our policy to avoid them."

It was stated, as the reason why this subject had been brought up, that some members had complained that the Guild was forming into cliques, and they me ant naturally so cial cliques:-

Mrs. Turner: --- "I have not seen or heard anything in the Guild that intimated social cliques in the slightest degree.

I have been specially proud of this society because it seemed

about as free from this feeling as anything to which I ever belonged. It is perfectly natural for one person to associate with another, rather than with some other person; it may be from superiority or may not; one that has a larger brain, a quicker intellect, or a tendency in a certain direction, is not going to find the same pleasure in associating with another who has not these tendencies and faculties; but that other one may be just as bright in other tendencies; and each goes where she belongs.

Mrs. Holman: --- The word "Clique" is generally used, as far as my experience goes, for a number who take an interest in them selves only, and in special things in which they alone are interested; and do not take an interest in the things that the others care for. To my mind, when cliques commence, good feeling ends, and I think it is very apt to create a feeling of superiority over the members who are outside of that clique. One of the great chams in our Guild has been that there has been a freedom from cliques; there has always been a feeling of friendly interest. There are, of course, circles of acquaintances, but one does not see our Guild members going off in corners, talking to each other, and not talking to other members I earnestly hope that we shall never have any cliques in that sense of the word; those of us who have bu siness interests, and those who have interests in other lines, can talk over these interests and do everything they can to further them."

There was quite a free expression of opinion in regard to the matter, and the speakers expressed themselves as being glad that the Guild was free from cliques, and sincerely hoped that this would always be the case, as they considered that it was the right policy to avoid them.

The officers of the Stenographic Circle explained the aims and success of the association, as far as the organization had gone.

The President of the Guild, Mrs. E. S. Turner, made the following address:-

"Our Diagnosis to-day:-

Realizing the importance of exact and well restrained statement on all occasions, we think we are safe in asserting that we are a full year older than we were a year ago. We will even go farther, and declare that our membership is larger; that our library is larger; that the general use of the the Guild-house is much increased, and for a greater variety of interests. The Stenographic Circle, which contains some of the best short-hand writers in the city, and recommends none under a certain criterion of speed and exactness, is a movement of importance to all woman stenographers. The year's

record of the "Willing Hands," which is twice as large as last season, shows that our members, laboring all day for their own support, can yet find time to spare to the outside help - less ones, from whom they can never get a return in kind.

Another direction in which we are aware of improvement is in the spirit of solidarity which keeps us alive to each other's interests. Of course, this spirit is not universal; in any collection of over 300 persons there will be a few who care only for themselves, and a larger number who, joining for the advantage of some special feature, and not having time or inclination to attend the general meetings, cannot be expected to think of the general welfare, or to feel in themselves the flow of the whole circulation. Nevertheless there has never been a year in which so many of our members have been, so to speak, re-fitted; have left uncongenial occupations for those more congenial, have found an outlet for the special faculties which had been lying unused. And this fitting of persons to places has been made possible largely by that mutual interest which induces one and another member to say to the managers or to the matron, "such a girl is covering buttons when she is fit for a clerkship; such a girl is fond of cooking, and would make a capital teacher, if she could get a chance for training; such a book-keeper maints hates routine work, and has the enterprise to go into business for herse if; such a seamstress, who se health will not bear confinement,

would be a treasure to that mother who wants, and knows how to treat, a superior care-taker for her children; such a machine tender is longing to study for a profession, but has no one to encourage her to try; such a machine tender would make a first-rate saleswoman; such a saleswoman, who is out of place behind a counter, would make a valuable out-of-door agent; such a forewoman would make a matron for an institution; such a hat liner was born to be an artist.

In these and other directions we have succeeded; in what have we failed?

I would say, in general terms, that we have not done enough; we do not bring in enough new members; we do not propose enough new projects; we do not sufficiently realize the power we might be in the city, with a larger membership, more money, more vim. We have such good times in a small society, where the members mostly know and feel at home with each other, that I fear we are somewhat loth to risk any change. There is danger that we may become too content to accept things as they are, to philosophize over ills instead of trying to mend them, to talk and discuss, and purr, and potter, instead of acting; to float round and round in our own little eddy, and let the full stream of effort and progress go by.

I have heard our Guild blamed, also, for not being more aggressive, not combining for instance, or joining other

combinations, for securing better wages, shorter hours, better conditions under which to work, better terms in general, in our relation to the whole labor market, In this I think we have our justification. It is not because we are satisfied, but rather that we are approaching these problems on other lines. We are aiming at better education, stricter business training, greater variety of occupation; the securing of a more advantageous attitude towards employers not by legislating for ourselves higher pay for commodities of mwhich we already offer a surplus, but by learning to offer more desirable commodity, by increasing our value, and consequently their need of us as employees. It has seemed to us that while we have nothing to urge against the methods of labor organizations for improving the condition of laborers the other steps, so far as women are concerned, are preliminary, and that these other steps will probably give us enough to do for some years to come.

But this does not mean surcease of effort - let us strive, on the contrary, for her own improvement in mind, in health, in capacity for self-support, each for her Guild fellow, realizing that she is in a sense her sister's keeper; bringing herself ever nearer to others in sympathy, and a desire to encourage and uphold; each for the larger aims which may be wrought through organization for the greater happiness of all womankind."

In regard to the Committee on MENTAL IMPROVEMENT, it

Mrs. Holman consented to remain Chairman with the understanding that the chief duty of the Committee would be the encouragement of circles in the Guild for special interests, etc.,
and not to include the original plan of arranging for lectures, and such things.

It was also stated that no change had been made in the Chairmanship and members of the WILLING HANDS Committee.

The following suggestions, prepared by Mrs. M. T. Gaw-throp, were unanimously adopted as rules for the government of the Committees:-

The FINANCE Committee shall examine and approve all bills, reporting the same to the stated meetings of the Guild before being paid by the Treasurer. When appropriations are ordered by the Guild, this Committee shall prepare the order, get the same signed by the presiding officer and Secretary, and forward the same to the Treasurer. Twice a year this Committee shall review the list of members, and render bills when necessary to those in arrears; will examine the annual report of the Treasurer, and prepare and present a statement of the membership of the Guild to the Annual Meeting.

The ENTERTAINMENT Committee shall two weeks after every stated meeting, and at such other times as may be desirable and expedient, provide entertainment for the Guild.

The LTBRARY Committee shall see that the books, magazines and papers in the Reading Room are kept in good order, properly classified and catalogued; and shall add new and second-hand books, either by gift from friends or purchase from time to time.

The Hospitality Committee shall seek to promote sociability among Guild members, and especially to extend to new members the courtesies of the House, and to acquaint them with the purposes and work of the organization, and with each other. It is advised that this Committee be divided into sub-committies, and assigned for duty, to each business meeting and

entertainment, thus making the work easier for the Committee as a whole. This Committee will also ascertain the number present at each meeting or entertainment, and report the same.

The Committee on WOMEN'S WORK shall collect facts and statistics in relation to the business places in the City, employing women, and will have such reports arranged as to be accessible to Guild members.

The GYMNASIUM Committee, in conjunction with that of the Executive Board, will arrange and supervise classes of Guild members, and especially will seek to interest members in the Gymnasium and its exercises.

The BUILDING FUND Committee, in conjunction with a committee from the Executive Board, will seek ways to increase the fund, and endeavor to induce members to take the collection cards. All cards are numbered, and a book has been prepared to enter such cards; when filled, they must be returned to Miss Helen Bell, Treasurer, with the money.

The FRIENDLY VISITORS will visit and correspond with sick and absent members, to console and encourage, and especially to try to win back those who have lost an interest in them.

Guild. To do this efficiently, it is advised that sub-committees be placed in charge of certain districts of the City.

This Committee shall also report the decease of any member of the Guild for appropriate action.

The WILLING HANDS formed to do work outside of the Guild for the sick and needy, and not for the Guild as an organization, shall report to the stated meetings all work done together with money contributed and expended.

The MENTAL IMPROVEMENT Committee shall organize circles for special study, or mutual interest and benefit, among Guild members.

All of these Committees should meet at regular and stated times, to consider and decide how best to serve the Guild. Notes should be kept of these meetings, and the work done by the Committees. All the Committees must report in writing to the Guild meetings."

It was moved, seconded and carried that the Chairman of each Committee be furnished with a copy of the rule relating to her Committee, and with a list of the names of the persons forming her Committee.

A motion to have the names of those on the Committees published in the "Working Woman's Journal" was carried.

Mrs. Gawthrop offered, providing the Chairmen of Committees would decide on a regular time for their meeting, to put the date of such meeting in the "Journal," in addition to the notices of other meetings: on motion, the offer was accepted.

It was moved, seconded and carried that the Treas rer

be authorized to forward the membership tickets by mail.

It was moved and seconded that the Chairmen of Committees apply to the Treasurer for such postal cards as they may need; carried.

A unanimous vote of thanks was tendered the retiring officers, who had served during 1888.

On mot ion, the meeting adjourned.

The regular business meeting of the "NEW CENTURY GUILD of WORKING WOMEN" was held this evening.

In the absence of Miss Jones, First Vice President, Mrs. Gallagher, Second Vice President, presided.

The minutes of the previous regular business meeting, held January 12th, were read and approved.

TREASURER (Miss Niles) reported a balance of \$192. on hand, to date.

FINANCE Committee (Mrs. Panzerbeiter) reported approval of bills amounting to \$24.89, and on motion this report was accepted.

Owing to the chairmen of the Committees appointed at the Annual Meeting not having had time, since the notification of their appointment, to call a meeting of their respective Committees, organize same and prepare a report of work done, on motion of Mrs. Gawthrop it was decided to dispense with the reports of Committees at this meeting.

Communications from the EXECUTIVE BOARD, - New members.

On motion, the following persons were elected members of the Guild:-

On behalf of the Gymnasium Committee, Mrs. Skinner announced that positively the last examination of the season would take place on Friday evening, the 15th, and urged a larger attendance at the evening classes.

Mrs. Holman called the attention of the Guild to the bill pending before the Legislature of the State: "An Act to regulate the employment of women and children in factories, mills, etc., and to appoint inspectors to enforce the same."

It was stated that the bill was designed to prohibit the employment of all children under 13 years of age, and compel certificates of age for all under 16. It was stated that by organizations taking appropriate action, writing letters and sending delegates to Harrisburg to interview the Senators and Representatives, the passage of the bill would be materially aided.

On motion, it was decided that the Guild appoint a delegate to go to Harrisburg to represent it in this matter.

Mrs. Holman was appointed such delegate, and on motion it was further decided that sufficient funds be appropriated for the expenses that will be incurred.

On motion, it was also decided that the President and Secretary be instructed to prepare a letter to the Senators and Representatives, approving the passage of this bill and endorsing the Guild's delegate.

A communication from the Philadelphia Women's Council,
"a society formed to promote greater unity of thought and
more effective action by an organized federation of the Associations of women engaged in philanthropic, religious, educational and social work in Philadelphia," was read, together
with the copy of constitution accompanying it. This Council
requested that the Guild appoint a delegate to represent it
at a meeting to be held in the Century Club Parlor, February
21st; and on motion it was decided that Mrs. Turner be appointed delegate from the Guild.

Miss Wilbur stated that she had in charge a petition to the Legislature forbidding the sale of tobacco to boys under 16 years of age, and requested that all so disposed go to the library and sign same.

A card from the Medical Aid Society, affording the best medical advice to women by women physicians, Drs. Tyson and Pepper consulting, was read; and it was stated that the fee would be 25%.

A lecture on "Woman Suffrage," by Clara Cleghorn
Hoffman, was announced for February 13th, and the Guild members were invited to attend, complimentary tickets having been
furnished for their use.

The discussion of the evening, - "Can Women learn carpentering?" - was opened by Mr. D. S. Holman, who present-

ed to the Guild a picture of carpentering as it existed more than 50 years ago. He based his argument for the negative side of the question on the assertion that physically women were not capable of filling the requirements of the carpenter trade; that their muscles were too weak for sawing and planing, driving 20-penny nails and jack-knife whittling; he gave an exhibition of whittling and splitting in order to illustrate the amount of skill required to do the former and the strength necessary to do the latter.

Miss Chase, who was obliged to be absent, sent her address for the defence in rhyme, Miss Abel rendering it; this was a very enjoyable paper, and besides this pleasant feature of it, it was quite a strong document for the affirmative side.

Mrs. Turner, Mrs. Blankenburg, Mrs. Treadwell, Mrs. Holman,
Mrs. Gallagher, Miss Ringwalt, Miss Altemus, Mr. Durham, and
others spoke in support of the affirmative. Many feats of
carpentering having been done by women were recounted; and
amongst the claims of those on the affirmative side the following were mentioned: many of the strictly feminine employments required just as much muscle as any branch of carpentering; the condition of the trade as it was half a century ago
has changed, and the carpenter of to-day finds ready for his
use (by means of machinery) all the articles necessary to

perform his work. It is believed that if women were given the same opportunity for physical development, in youth, that men have all along enjoyed, they would be perfectly able to meet all the problems connected with their taking up carpentering, in its completeness, and acquit themselves with credit to their sex.

Mr. Holman having finally acknowledged the possibility of women learning to be carpenters, in spite of the ponderous tools and the hemlock, and this admission removing from the field the single instance of contrary opinion, the discussion closed, the unanimous verdict being that the question had but one answer, - and that decidedly "yes."

Mr. John S. Durham, representing the Progressive Workingmen's Association, spoke on behalf of the educated colored
women of Philadelphia, urging their claims for representation
in the places of employment in this City. He asked that the
Guild, as an organization, consider the question of allowing
them to work beside them; he stated that when employers had
been approached on the subject, they had said that they were
willing to give these colored women a chance, but that their
white employees had declined to work with them. Mr. Durham
stated that what the educated colored woman of Philadelphia
needed was a diversity of employment, - an opportunity to earn
money; that she did not ask to be placed on a social plane
with those white women with whom she worked, but, in a business

sense, to be tolerated and treated in a manner befitting the justice of her claims.

At the conclusion of Mr. Durham's address, it was suggested that, for the next business meeting of the Guild, the subject for discussion be, "Shall we, as working women, be willing to work with colored women;" and on motion this subject was decided upon.

Chase, Chairman) reported that on February 23rd Mr. Perry had made a very interesting address on "Iron," which was appreciated and enjoyed; also that entertainments as far ahead as June had been planned. HOSPITALITY Committee (Miss Connelly, Chairman) had no report. It was suggested that some money be appropriated to this Committee for badges, and on motion the Chairman was authorized to purchase sufficient ribbon for her Committee. GYMNASIUM Committee (Miss Murphy, Chairman) No report. FRIENDLY Visitors (I. E. Turner, Chairman) reported that six members had been visited, and that one boquet and one blooming plant had been sent to sick members. On motion it was decided to appropriate \$5. for the use of this Committee in its work.

MENTAL IMPROVEMENT Committee (Mrs. Holman, Chairman) reported that a meeting had been held, at which it was decided request the Guild to change its name to "Committee on Special Interests." It was further stated that the Stenographic Association and its practice class were in a flourishing condition. It was suggested that the book-keepers in the Guild form a book-keepers' association, somewhat on the plan of the Stenographic Association, the object being to raise the standard. It was also suggested that a conversational club be formed, to meet every two weeks for the purpose of discussing the political, scientific, historical and literary questions of the day. Miss Graeff spoke of the desirability of having a conversational club formed, and offered to aid such a project. Mr. Richardson spoke warmly in favor of the formation of a book-keepers' association, promising to give it all the assistance in his power. On motion, it was decided,

Mrs. Turner, our delegate to the recent meeting of the Women's Council, reported that at this meeting the permanent organization was not completed, and that representatives from 17 societies were present; she also read the proposed constitution, and stated that it would be of advantage to the Guild to join the Council. On motion it was decided that Mrs. Turner represent us at the meeting to be held on April 13th, and

that she be authorized to say that this Guild will become a member of the Council.

Miss M. Colville tendered her resignation, and, on motion, it was accepted with regret.

Mrs. Holman, who had been appointed delegate to represent the Guild at Harrisburg in connection with the Factory Inspectors' bill, stated that on the 21st of February, in company with the representative of the Workingmen's Society, she appeared before the Committee on Corporations, to whom the matter had been referred, - presumably for the purpose of having the bill killed. In the original bill a distinction was made in favor of women, not allowing any woman under 2], or any boy under 18 to work more than ten hours per day; by request, this was amended to read that no minor (under 21) be allowed to work more than 10 days in any day, or 60 hours per week. agree with the laws already made, the age at which children might work was changed from 13 to 12 years. The struggle was over the inspectors, the Committee not approving of them. They objected to having women, but finally agreed to let it go, reducing the number of inspectors from J inspector, J assistant inspector and 8 deputy inspectors, two of whom might be women, to 1 inspector, no assistant inspector and 4 deputy inspectors, two of whom should be women. Later, the statement was made that the Committee had decided to report favorably, which, it is conceded is mainly due to the pressure brought by the representatives of societies. It was further stated that the bill was almost sure to pass the Senate, and if it did so there was very little doubt of its passage through the House.

On motion, Mrs. Holman was tendered a unanimous vote of thanks for her work at Harrisburg.

It was stated that there had been some talk about starting a fencing class in the Gymnasium; the probable expenses in connection with tuition and outfit were named, and all those who desired to join such a class were requested to give their names.

Attention was called to the frieze that had been finished by Miss Ringwalt and Miss Abel, and, on motion, they were tendered a unanimous vote of thanks for their services.

Attention was then given to the subject of discussion for the evening, - "Shall we, as working women, be willing to work with colored women." Mr. John S. Durham and T. J. Minton, Esq., representing the Colored Workingmen's Association, Mrs. Frances Jackson Coppin and Rev. H. L. Wayland, made addresses in favor of allowing colored women those privileges which justice demanded in view of all the circumstances.

Mr. Durham requested that the Guild hear what might be brought before it, in its own time give the matter serious consideration and decide in a spirit free from mere prejudice. He stated that whatever prejudice there might be in the busi-

ness world was, virtually, confined to employees, and that the employers did not, as a rule, allow sentiment to enter into the matter. He stated that his Association was anxious to go back to these employers and say that there is one organization of working women in Philadelphia that will raise no objection to working with refined and educated colored women, and he said that this would materially assist the Association in its object.

Mr. Minton urged that these colored persons be regarded for their merits, and not denied recognition on the mere ground of complexion; he called attention to the fact that there are numbers of colored men and women fully qualified to fill the highest positions, but who are refused their rights on account of their color. Referring to the general impression that the colored people, as a class, were lacking in ambition, indo lent and thriftless, he said that if there was any truth in it, it was due to the fact that white people did not extend to them a helping hand, did not encourage those who showed a disposition to attain something higher, and took no interest in them. He said that the boy or girl who was ambitious and brave emugh to struggle for an education and then, after obtaining it, risk public opinion and make strenuous effort to obtain that employment which his or her education warrants, is finally forced to give up in despair, and sink into idleness and crime. He stated that there was a perceptible

diminution of the prejudice, and that, in the best circles, it existed in less and less degree; he also referred to the fact that abroad color was a considered a distinction. He cited instances in which colored men had lived down the feeling that their color had incited, and spoke of the injustice of white people believing that, because an individual was colored, this circumstances detracted from his capability.

Mrs. Coppin made an eloquent appeal that prejudice be set aside, and that merit have its rightful place, irrespective of color. She spoke of the humane side of the question; of the many intelligent, refined women who, though fitted and intended for something more congenial, had worn out their life in toil that was too much for them to bear.

Dr. Wayland attributed the whole trouble to prejudice and public opinion merely. He said that progress, without doubt, had been steadily made, and that, although there would be no violent revolution, he thought there would be more rapid progress than ever, even though the direct way had not yet been made clear.

In addition, Mr. Durham earnestly requested the Guild to bear in mind that the educated colored man and woman did not consent to be put on a plane with the ignorance with which the colored race of the country is afflicted; that they insisted that the individual be considered, and not his color.

The lateness of the hour prevented further consider-

ation of the subject, and on motion it was decided that this discussion be continued at the next meeting.

It was stated that there was no permanent secretary, and it was suggested that some action be taken in regard to the matter. On motion, it was decided that a committee be appointed to provide a secretary, such committee to be named by the chair; Mrs. Gawthrop, Miss Niles and Miss Hallam were then appointed.

On motion, the meeting adjourned.

The members present seemed to favor a printed copy, and on motion the matter was referred to the Library Committee, to ascertain the cost of printing, with instructions to report at the next regular meeting.

man) reported that the Stenographic Association had its regular monthly meeting on March 28th, with a large attendance, and manifestation of great interest; that the Chautauqua Circle was progressing in its studies; that the Committee had met at the Guild on the 25th of March to meet the Guild members who wished to form a conversation class; and as there were but two, beside the Committee, present, it was decided to postpone the effort until May, when the members would be less occupied; that there were so few book-keepers on the roll of the Guild, it would not be worth while forming a Circle in their interests.

WILLING HANDS (Mrs. Phillippe, Chairman) stated that they had loaned \$5.; had distributed 10 pieces of clothing, and paid a poor woman's rent, etc., etc.

BUILDING FUND (Miss Garrison, Chairman) It was reported that this Committee had about \$800. under its control. Communications from the Executive Board:-

Mrs. Skinner called the attention of the Guild to the advisability of having some rule in connection with treatment of delinquent members, and presented the following as an addition to the proper by-law, which, being made a motion, was seconded and carried:-

> "Any member failing to pay her dues at the expiration of three months, will forfeit all rights of membership until renewal."

Mrs. Gawthrop, Chairman of the committee appointed to provide a Secretary for the Guild, reported that the Committee desired to offer the name of Miss Leonora C.J. Bock;

on motion, it was decided to accept Miss Beck as Secretary, with acclamation.

Mrs. Skinner stated that the Guild Journal needed more general pecuniary support on the part of the members, and suggested that those who had not already subscribed do so at once.

Mrs. Holman asked the Guild to join in a general effort with the other women's societies of the City against allowing men to expectorate in street cars; she read the form of a petition proposed to be sent to the street car companies, to the effect that they have notices placed in their cars prohibiting this revolting practice.

It was moved and seconded that this be passed by the Guild, and ordered signed by the President and Secretary; as the President requested time to think about the matter before signing, Mrs. Holman, who had offered the motion, was requested to withdraw same, which she consented to do, stating, however, that she did so under protest; action in the matter was, therefore, postponed.

The subject for discussion was the same as at the previous business meeting, having, upon motion, been continued:"Shall we, as working women, be willing to work with colored women."

The following Guild members made remarks: - Mrs.
Turner, Mrs. Holman, Mrs. Gallagher, Mrs. Phillippe, Mr. Holman,

Misses Cameron, Miller, Keating, Connelly, Jones, Graeff, Ringwalt, Whitely, and others.

The statement was made that, if while in slavery the colored race had been wronged, we, by not helping these people now, are also wronging them, and to a greater extent than we estimate.

While acknowledging that a large proportion of the opposition to allowing colored women to enter the ordinary avenues of employment open to white women, comes from the latter, it was stated that much of the antagonism came from the employers, though it might not be openly expressed; it was also said that the feelings of customers would have to be considered in dealing with the question of colored sales women, some of them having decided views on the subject, and a marked objection to dealing with them in that capacity. It was stated that it was one of the characteristics of the colored race to assume more than circumstances warranted, and that if given an opportunity, they would soon show a tendency to go beyond bounds; also that there was danger, in close contact, of becoming too familiar, and, in time, bringing about marriage between the white and black. It was further remarked that the public was not yet ready for it; that, to be successful, those who are opposed to the whole idea must be gradually educated in the desired direction.

In regard to the fact that so many hold back on

account of what others might think, it was urged that personal feelings be set aside, and that we force ourselves to see and do what is right in the matter; that in dealing with this subject we must not think so much of the colored woman of to-day, but of the future, when she shall have attained something higher in the world of education and training; and although sharing employment with her may still more crowd the line seeking employment, the good done will more than counterbalance the inconvenience to some of the whites. As a means of protection, on the score of wages, it was predicted that sooner or later we, as have others in the labor world, will have to seriously consider the wisdom of having them on an equal plane with ourselves, doing the same work and demanding the same remuneration; otherwise, by their offers to work for less, we will be set aside.

Everything considered, it was the general opinion that, in justice, the colored woman should have a chance to show what she can do; and the few who spoke on the negative side of the question gave the impression that they would not let their sentiments interfere with the improvement of the condition of the refined, educated colored woman.

Upon suggestion, the members present who felt willing to work side by side with colored woman stood; as did also,
in turn, those who felt that they could not do so with any degree of satisfaction; upon being counted, those in favor num-

bered 29, and those not in favor 7. This practically ended the discussion, and, on motion, the meeting adjourned. Ida E. Turner, Secretary pro tem.

The minutes of the previous business meeting were read, and with the exception that the bill for Journal No. 7 which was wrong-ly reported "as ordered to be paid" was withdrawn, were approved.

The Finance Committee, Mrs. Banzerbeiter, Chairman reported as follows:-

The Entertainment Committee, Miss Chase, Chairman reported that Miss Helen Hinkley was expected to give a talk on Johnstown.

The Hospitality Committee, Miss Connelly Chairman, stated that at the Social held October 5th, 41 were present. A talk on the National Flower resulted in 28 votes in favor of the golden rod, 2 for the morning glory and 2 for the Indian Corn. Many little articles were read, and some pleasant poems. Mrs. Earle gave a reading from King Lear; after the reading music and dancing.

The Library Committee, Miss Hallam Chairman, announced the accession of the following books to the Library:-

"Working Women in Large Cities", by Mr. Carroll D. Wright Commissioner of Labor, Washington, for which the Chairman in the name of the Guild has written him a letter of thanks. Also "Prisoners of Poverty Abroad", and "Our Town" presented by Mrs. Mary T. Gawthrop.

Committee on Women's Work, Mrs. Moser, Chairman. No report. It being indirectly learned that the chairman of this Committee was out of town, and as she had written that she had no intention of remaining longer in the Guild, this Committee was instructed to elect a temporary chairman to serve until the next annual meeting.

Gymnasium Committee, Miss Murphy Chairman, sent the following report:—"The Gymnasium Committee as a Committee is a failure, possibly my fault. I called a meeting soon after being elected but Miss Easton and myself were the only ones present. Miss Crawford sent apphabalexplaining her absence. I intended to call another one soon but forgot to do so. From all I could learn we were supernumeraries to say the least, as all the business is in the hands of the Board. The members of the different classes last winter were nearly all enthusiastic and enjoyed it so much that they brought their friends to help them. So far as I know not one member did the work simply as a duty. Our greatest good came from the pleasure therein and Miss Sage's wise management of her classes added all that was needed.

The Friendly Visitors, Miss Turner chairman, sent two bouquets to sick members &c. and also submitted the following report on the

the special work they had undertaken:-"Of the 80 delinquents whose names were handed to them four weeks ago, they have succeeded in seeing 37; 20 were out when calls were made; 6 have been addressed by letter; by reason of residing out of town &c. 9 were beyond reach; this makes a total of 71, leaving 8 for attention in the next four weeks it having been impossible to attend to their cases to day.

In the opinion of the Committee, it is probable that about 23 will renew; in fact 2 of this number have paid their dues to the Visitors and 2 others claim to hold receipts for this year. In every case in their delicate mission the Visitors were received with uniform courtesy. Almost without exception the reason on the part of those not deciding to renew was in no way connected with whatever impressions they had formed of the Guild; distance, late hours of employment, other interests, sickness &c cover the matter in almost every case.

In several instances the little notice in the Journal had given the impression that those who were back in payments would not be re-instated; others had overlooked the fact that they had not paid their dues; and, altogether, this "visiting reminder" has cleared up some misunderstanding, and will doubtless restore to the Guild those who might, if left alone, quietly dropt out The Committee would suggest that the Journal put a prominent notice in the November Issue to the effect that those three months or more in arrears will be restored to full membership by settling

the amount due. This will emphasize what has been said in the rounds of visits now almost completed.

Committee on Special Interests, Miss Ringwalt, Chairman, stated that the Stenographic Circle was in a promising condition and would hold its Annual Meeting on the 10th inst. The Chatauqua circle is also now being formed; will meet next Saturday night and after that on alternate Saturdays. Miss Turner stated that the Circle had been formed two years ago and for a time had gone steadily forward but now its membership had begun to declime some being obliged to drop out. The Course for this season will include the Literature of the Roman Empire, Physics, Church History, a little of Art &c. The expenses of the Course will not be over \$7.00, \$2.50 of which will be needed at first and the remainder can be spread over the year. Mrs. Holman has charge of the Circle.

The Conversation Class under the charge of Miss Graff would like to continue during the winter if sure of a membership of at least six, but do not wish to do it for less than that number. It is proposed to change the night from Friday to Tuesday.

In accordance with instructions given at the last business meeting the Chairman of this Committee had written to Miss. Thomas asking for terms &c. for giving a lecture on health before the Guild. She replied that she would be glad to give a lecture in November and would reduce her charges one half, or \$25.00 and expenses.

In August \$1.00 was spent for co-coabaine, \$10.00 a temporary lean, \$7.00 country week; money was also spent for medicine, postage, washing, groceries, &c. &c.

They also presented the following in again to the special work which they had undertaken; The "Friendly Visitors" take pleasure in stating that they have now fully completed their labors in connection with the list of delinquent members put in their chape a few weeks ago. In the report presented October 19th, of the 80 names, 72 were accounted for, and a detailed report gave all the particulars; since that time the remaining 8 have been looked up, it and a detailed report of them is attached, also some additional information regarding a few of those already reported upon.

As we had the gratification to state last month, the principal reason on the part of these delinquents for allowing themselves to become backward in payment has been forgetfulness; many have overlooked the fact that they have been in arrears, and have been gald to be informed; others were under the impression that they had paid, and were relieved when they found that by a little transfer of funds, the affair would be all right and they would be restored to full membership.
